# What is Dual Credit?

Elgin Community College and its partner School Districts offer several dual credit program options to allow high school students to enroll in college courses. Students earn simultaneous high school and college credit. These programs provide a way to save time and money toward attaining higher education goals, experience college life, and prepare for a successful transition after high school.

Each Dual Credit program offers a unique opportunity to accommodate students' academic, behavioral, or social needs. **A brief summary of the available programs is outlined below.**

## Full-Time Dual Credit Program at ECC

- Senior enrollment (One-year program )
- Junior enrollment (Two-year program)
- Earn 24+ transferable credits each year
- Minimum of 12 credit hours each semester
- Courses are chosen from the Associate of Arts or Science degree plan

## Part-Time Program: General Education at high school

- Senior Enrollment - All qualifying students
- Sophomore/Junior Enrollment - Course dependent
- Courses offered at the high school building
- Enrolled in 1-3 courses each semester
- Maximum of 11 credit hours each semester
- Courses available in English, Math, Spanish & Basic Nursing Assistant Program/CNA, Automotive, Industrial Manufacturing Technology, & Welding

# Why Enroll?

Students opt to participate in Dual Credit courses to:

- Experience rigorous coursework and experience the college environment
- Earn college credit to help gain a head-start on college courses
- Stand out in the college admission process
- Develop skills, behaviors, and knowledge to support their transition to college
- Save money – students should follow up with their district to see what costs are covered

## Program Details

Below are details of the various types of Dual Credit programs: Full-Time at ECC, and Part-Time at your high school.

This information should help students determine which option best aligns with their academic plan and career interests. Students should discuss transportation options with their high school counselor. A representative from the high school will share information about tuition, fees, and other costs related to the different dual credit programs.

School District U-46 has elected to offer the following programs in partnership with Elgin Community College.

## FULL-TIME DUAL CREDIT AT ECC

### SENIOR ENROLLMENT (1-YEAR PROGRAM)

- Students enroll in 4-5 courses each semester at the ECC campus
- Courses add up to a minimum of 12 credit hours each semester
- Students may earn 24+ transferable credits
- Students complete COL 101-College Success during their first semester
- Students are required to attend Friday meetings with the U-46 lead counselor
- Students meet with ECC's academic advising department to develop academic plan
- The school district reviews selected courses to ensure they meet the student's high school graduation requirements
- Students should discuss with their high school counselor, options for transportation to their high school for after school activities
- Students may participate in IHSA sports and activities at their high school, though they may be impacted by the meeting times of course sections

- Students will review the textbook policy with their high school counselor

## JUNIOR ENROLLMENT (2-YEAR PROGRAM)

- Students enroll in 4-5 courses each semester at the ECC campus
- Complete 60 credits/degree requirements in two years (i.e. 15 credits per semester)
- Summer courses may be required between junior and senior year
- Students complete COL 101-College Success during the first semester.
- Students are required to attend Friday meetings with the U-46 lead counselor
- Students meet with ECC's academic advising department to develop an academic plan
- The school district reviews selected courses to ensure they meet the student's high school graduation requirements
- Students are responsible for transportation to their high school for after school activities
- Students may participate in IHSA sports and activities at their high school, though they may be impacted by the meeting times of course sections
- Students will review the textbook policy with their high school counselor

Students are advised to register for course sections scheduled Monday-Friday from 8:00 a.m. to 3:15p.m. In order to register for required & desired courses, some courses may need to be scheduled outside of this timeframe. Evening hours and online section options can be discussed with your counselor.

**Class schedules will not accommodate students' work schedules. The ECC academic calendar (i.e. the start and end date of each semester) may differ from the school districts' calendar.** Students in the full-time dual credit program are expected to follow the ECC academic calendar

## PROGRAM QUALIFICATIONS

- Must be and remain a School District U-46 student in good standing
- Current sophomore or junior at the time of application
- Strongly recommend to have a 3.00 cumulative unweighted high school GPA at the time of application
- Must maintain a 2.00 GPA while enrolled at ECC
- Demonstrate college-readiness – Must have qualifying scores (PSAT/SAT/ACT or ECC Placement Tests)

- Meet other high school requirements as noted by U-46 district policies
- Submit a dual credit U-46 agreement
- Enrollment is limited and determined by the school district

## PART-TIME DUAL CREDIT AT THE HIGH SCHOOL

- Current freshman, sophomore, or junior (course dependent)
- Students enroll in 1-3 courses each semester
- Maximum of 11 credit hours each semester
- Course options offered at the high school
- Course options are pre-selected by the school district
- Enrollment is limited and determined by the school district

## PROGRAM QUALIFICATIONS

- Strongly recommend to have a 3.00 cumulative unweighted high school GPA at the time of application
- Demonstrate college-readiness – Must have qualifying scores (PSAT/SAT/ACT or ECC Placement Tests)
- Meet other high school requirements as noted by U-46 district policies

## PART-TIME IN-HIGH SCHOOL DUAL CREDIT COURSES

The following is helpful when selecting courses with the help of your school counselor:

- **General Education:** In addition to courses required for specific majors, General Education courses satisfy a required set of core courses considered an essential foundation for a well-rounded education. NOTE: All General Education courses can also count as elective credit.
- **Elective:** Each program/institution sets a minimum number of credits that students must complete separate from General Education that may include courses requirements for your intended Major/Minor.
- **Prerequisite:** Courses that require the successful (C or better) completion of another course in order to continue in the specified sequence (i.e. Biology, Chemistry, Mathematics, and/or Physics) are marked as "Prerequisite".
- **Career & Technical Education (CTE)** courses align with an Associate in Applied Science degree or certificate program, which prepare students for careers and/or employment.
- CTE credits earned do not necessarily transfer to a baccalaureate program

- Participation in high school activities may be impacted by the meeting times of course sections selected by the student

- Automotive Service Technology
- Basic Nursing Assistant Training Program and Clinical Lab Technology

## Financial Aid & Minimum Academic Standards Requirements

Financial aid is not available to dual credit students; however, dual credit courses count as credits attempted/completed and are included when determining a student's academic progress and eligibility for future financial aid.

The Standard Academic Progress (SAP) policy measures a student's academic progress in three ways. Students must meet all three standards to be in good status.

### A. Cumulative Grade Point Average

You must achieve and maintain at least a cumulative grade point average of 2.00 at the College, including transferred, repeated, and remedial credits.

### B. Cumulative Completion Rate

You must successfully complete at least 66.67% of all credit hours attempted at the College, including transferred credits.

- Grades of A, B, C, D, CR, and S count as credit hours attempted and completed.
- Grades of E, F, W, WF, AW, and Z count as credit hours attempted but not completed.
- Grades of I, U, AU, NR, and NC do not count in this calculation as they are considered neither attempted nor completed.

Note: Transferred, repeated, and remedial courses are included in determining if you meet the cumulative completion rate standard.

### C. Maximum Time Frame

You must complete your program of study within 150% of attempted credit hours relative to the credit hours required to complete the program.

- Example: A degree-seeking student may attempt no more than 90 credit hours in order to complete a 60-credit hour program; a certificate-seeking student may attempt no more than 45 credit hours to complete a 30-credit hour program. If during the SAP review it becomes clear that you cannot

mathematically complete your program within the maximum time frame, you may become ineligible for financial aid.

Note: Transferred, repeated, and remedial courses are included to determine if you meet the maximum time frame standard.

## What Is Next?

1. Review the dual credit program options carefully
2. Talk with your parents/guardians about the program options to identify which may be the best fit for you
3. Schedule a meeting with your high school counselor to confirm which program may work best for you, including reviewing criteria for participating in these programs and ECC minimum requirements for enrollment
4. If you are interested in the full-time dual credit program, submit the Dual Credit U-46 Interest form found at [u-46.org/dualcredit](http://u-46.org/dualcredit). **You will not be considered for the full-time program if this form is not submitted.**

## How do I Apply?

### Full-Time Dual Credit Program

Full-time dual credit students take all their courses at ECC. This section provides information about the application and testing process for students applying to an ECC Dual Credit program. Students must meet with their high school counselor to review the application process, timeline, and deadlines specific to their school district.

All students must complete the following process:

1. Complete all high school requirements: Strongly recommend a cumulative unweighted GPA of 3.0 or better and have satisfactory progress towards high school graduation.
2. Complete the Dual Credit Initial Interest Form found at [U-46.org/dualcredit](http://U-46.org/dualcredit).
3. Follow the application instructions and complete all testing requirements by January 31<sup>st</sup> for priority consideration or February 15<sup>th</sup> for final consideration.
4. All application materials must be completed and received by **February 15<sup>th</sup>** to be considered for the full-time dual credit program.



All full-time dual credit admissions decisions will be communicated on **March 1, 2024** and will be based on students meeting all ECC and high school requirements. High schools will communicate admission decisions, and ECC will follow up with an invitation to a Welcome Night event for students accepted into the Full-Time Dual Credit program.

## Part-Time In-High School Dual Credit Program

Part-time Dual Credit courses are a part of a student's 8 period schedule at their high school. All students must complete the following process:

1. Complete all high school requirements: Strongly recommend a cumulative unweighted GPA of 3.0 or better and have satisfactory progress towards high school graduation.
2. Work with your school counselor and register for the in-high school part-time dual credit class during your course selection meeting.
3. Submit an ECC Application following the Dual Credit Application Instructions in the next section of this document. Please follow these steps carefully, failure to do so will result in an incomplete application

After students discuss their eligibility with their high school counselor, they need to complete an ECC application. Instructions on how to fill out the application are included in the following section. Please follow these steps carefully; failure to do so will result in an incomplete application.

You can register by computer or right on your smart phone by entering <https://elgin.dualenroll.com/> and clicking on **CREATE MY ACCOUNT**. Once you click CREATE ACCOUNT, you'll receive either a text message with an activation code or an email with a link to confirm your account. You must confirm your account before you can proceed with the registration. After the application is processed, ECC will provide information on how to complete the required ECC placement tests or submit qualifying test scores.

The ECC Dual Credit Office will communicate with high schools throughout the application and testing process. Confirmation of application and test scores will be shared with the high school counseling staff on a continuous basis. Students are highly encouraged to follow up with their high school counselor with any questions regarding their application and admissions status.



As a reminder, all admissions decisions will be based on students meeting all ECC and high school requirements. High schools will communicate admission decisions, and ECC will follow up with an invitation to a “Welcome Night” event at ECC for students accepted into Dual Credit.

Application Timeline and Deadlines:

1. Complete the Dual Credit **U-46** Program Agreement and submit it to your school
2. **Application Deadline:** February 15, 2024
3. **Placement Testing Deadline for Full-Time Program:** February 15, 2024
4. **Admission Decision:** March 1, 2024

## Dual Credit Application Instructions

Steps to Complete Your ECC Application Using DualEnroll:



Students will be provided a link to access the Elgin Community College application on the DualEnroll platform.

CREATE ACCOUNT

- When the student account is created, the log in screen will display a message that the student has signed up successfully and alert that an email will be sent to the student email provided to confirm their account.
- Student must click **"Confirm my account"** to continue. This step will automatically open the application on the DualEnroll site.

**Note-** The application process may be revised slightly. Students are encouraged to connect with their high school counselor for assistance.

# Submitting Transcripts

Elgin Community College and the high school will confirm students' current unweighted high school GPA before a final admission decision is determined.

All students admitted into a Dual Credit program will have their final (2023-2024) high school transcript submitted no later than June 30, 2024. **Note: Your high school administration will send an official transcript to the ECC's Admissions Office.**

## Preparing for Testing

Placement tests assess students' skill levels and are used to confirm academic readiness to enroll in college courses. Prior to taking the placement test, review "How does the test work" and "How Can I Prepare for the test" sections on the pages below for access to practice questions and examples. ## Testing Information

After submitting an online application, students will need to complete the required placement tests associated with their program/courses. If students have qualifying PSAT, SAT, or ACT scores, they must submit their score report to the ECC Admissions Office.

All students must meet the minimum college-level benchmarks in reading, writing, mathematics, and foreign language required by the courses/program for which they are seeking enrollment in next academic year.

An appointment is required for testing. Visit [www.registerblast.com/elgin](http://www.registerblast.com/elgin) to schedule an appointment OR scan the QR code below.



Students that plan to complete ECC's Placement Tests are limited to two (2) attempts for the Reading and Writing tests, and five (5) attempts for the Math test.

**NOTE:** The allotted attempts do not reset after high school graduation. Reading and Writing test scores expire after five (5) years and two (2) years for Math scores. If a student plans to continue at ECC after high school graduation, then they should be aware that the scores they earn while applying to one of the Dual Credit programs may be used for placement and enrollment.

## Testing Accommodations

## PSAT/SAT or ACT Testing

Students can use their qualifying PSAT/SAT or ACT to fulfill their ECC placement requirements. Please follow up with your school counselor to learn more about these testing opportunities.

## Testing Requirements – Benchmark scores

### Full-Time Dual Credit Program

Below are the benchmark scores that students must earn to meet the Full-time Dual Credit Program's testing requirements. Students in the full-time program will select from courses that require they meet the reading, writing, and mathematics minimum competencies

### Math Part-Time Dual Credit Courses at ECC

This is for students who have completed all their math options within School District U-46. Students are required to meet the minimum competencies associated with their ECC Math course/s. Students can fulfill these requirements by way of their PSAT/SAT or ACT scores. If students need to complete ECC's placement exams, additional information is provided below detailing which exams and cut-off scores are required.

## Part-Time In-High School Dual Credit Program
