

Larsen Middle School Parental Involvement Policy 2020-2021

PART I. GENERAL EXPECTATIONS Larsen Middle School agrees to implement the following statutory requirements:

 - Testing results sent home to parents as they become available throughout the year, including, but not limited to IAR, MAP, and ACCESS, with explanations of the meanings of the scores
 - Parent/teacher conferences throughout the year
 - Phone conferences throughout the year
 - Individual conference with principal and/or teacher
- 5. Larsen Middle School will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
 - Including parents on the School Improvement Team
 - Encouraging PTO meeting participation
 - Offering Parent Teacher Conferences throughout the year
 - Offering Individual conference with principal
- 6. Larsen Middle School will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by: The IAR and ACCESS reports will be sent home with the students in their first progress report and include a detailed explanation of the results.
- 7. Larsen Middle School will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by: Our district notifies the parents of this situation via a letter within the agreed upon time frame.
- 8. Larsen Middle School will provide assistance to parents of children served by the school, as appropriate, in understanding the following topics by undertaking the actions described in this paragraph:
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress
 - how to work with educators
- 9. The staff at Larsen School is committed to involving our parents in numerous activities that will keep them informed of their child's progress and performance by:
 - Provide support in Distance Learning for parents on Infinite Campus, Canvas and Zoom
 - Sending home information via Connect Ed and texts
 - Holding an annual Curriculum Night
 - Posting grades and district assessment results every 3 weeks in Infinite Campus

- Offering Parent/teacher conferences
- Holding reading and math nights
- Classroom newsletter and/or classroom webpage
- Parent-teacher correspondence
- Offering Individual conference with principal or teacher as needed throughout the year
- Encouraging PTO Meeting participation
- 10. Larsen Middle School will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
 - Provide Distance Learning Support with Technology
 - Include parents who are already involved in parent leadership group positions in the committee groups of the school
 - Encourage school staff to participate in the PTO
 - Talk about Parent Cafe at school staff meeting to encourage staff and parents to participate
- 11. Larsen Middle School will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
