

## **Bullying Defined**

- Common usage vs. Technical usage
- Technical bullying defined by the impact that an incident has on a victim
- INTENSITY, DURATION, FREQUENCY: Either a single, severe incident OR more than one (pervasive) incident

IL School Code & U-46 School Board Policy (7.193) "...any <u>severe or pervasive</u> physical or verbal act or conduct including communications made in writing or electronically, directed toward a student or students that has or can be reasonably predicted to have the effect of one or more of the following:" (Emphasis added)



## Bullying Defined (cont'd) - Impact

(Threats)	"Placing the student or students in reasonable fear of harm to the student's or students' person or property;
(Health)	Causing a substantially detrimental effect on the student's or students' physical or mental health;
(Academics)	Substantially interfering with the student's or students' academic performance; or
(Participation)	"Substantially interfering with the student's or students' ability to participate in or benefit from the services, activities, or privileges provided by a school. "



## <u>U-46 Student Code of Conduct</u>& Bullying

- On the school level, administrators (e.g., Principals, Deans) are responsible to complete bullying investigations
- Behavior Event Consequences Range of Level 2 - 4 and possibility of referral to police, on a case-specific basis (e.g., sexual harassment)

#### Behavior Events - Offense Types and Levels

Level 1/Teacher Managed Behavior – Behavior events that disrupt the learning environment that are not serious enough to warrant administrative management of the behavior event. Level 2-4/Administrator Managed Behavior – Behavior events that disrupt the learning environment and are serious enough to warrant administrative management of the behavior events there referred by the teacher to the administrator or behavior events that are handled by the administrator due to the nature of the behavior event.

The following chart provides guidance as to which behavior events result in teacher managed and/or administrator managed assignment of consequences and interventions:

- International Institute for Restorative Practices
- Everyone has value in the community
- Restore relationships
- Repair harm



## **Types of Restorative Practices**

- Conversation
- Conference
- Circle



## **Strategies for Parents**

- After-School Conversation
  - Prioritize the positive
    - "Tell me about a time when you laughed today"
    - "Tell me about a time when you made/built/created something today"
  - Identify the challenges and encourage a confident, appropriate response
