In the interest of safety and best use of the limited parking facilities available, Elgin High School requires the Parking Permit Request Form on the reverse side to be completed for all students who wish to drive to school. *Parents and students need to understand that driving to school and use of the student parking lot is a privilege.* All parents must provide evidence of the necessity for motor vehicle use in the "Request is made for the following reasons" section of this f form.

All policies and procedures regarding driving to school and the use of the school parking lot as outlined in the Parent/Student Handbook apply. If this application is approved, a parking permit will be issued upon the <u>payment of the \$100.00 fee, proof of insurance, and presentation of a valid driver's license.</u> Students and parents must understand that <u>any violation of the closed campus policy will result in suspension or revocation of any driving privileges without refund of the parking fee.</u>
