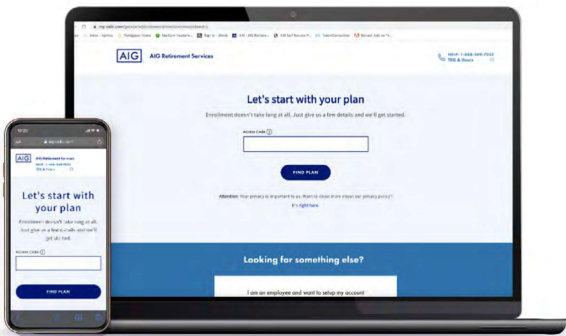


How to enroll in your plan.

Visit AIGRS.com and click the enroll button to get started or download the mobile app. Then follow these simple steps to enroll in your retirement plan.



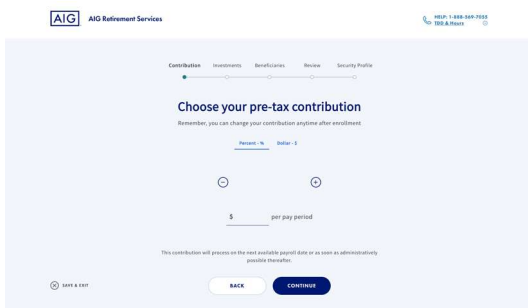
1. Plan and personal information

To begin, please input your plan access code and the requested personal information. Don't know your access code? That's okay, contact your Human Resources/Benefits team or your AIG Retirement Services financial professional to get it.

- 01480300 - 457(b) Roth only

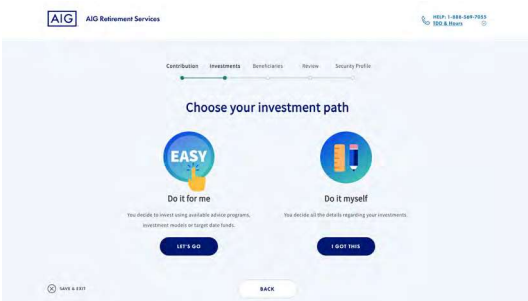
2. Contributions

Next, select your pretax contributions by either percentage or dollar amount. Remember, you can change your contribution anytime after enrollment.




3. Investments


4. Beneficiaries
