DIRECTORY INFORMATION for School Year 2015-2016

School District personnel may release "directory information" concerning students to members of the general public upon request. "Directory information" includes the following: student's name and address; parents' name and address; birth date; gender; grade level; academic awards and honors; participation in school-sponsored activities; organizations and athletics; major field of study; and period of attendance in school. Parents who request that directory information not be released should notify the school on an annual basis before the beginning of the school year.

Please note that by electing to opt out of directory information publication, your student's directory information will not be in the school student directory, activity or athletic programs, school newsletters, local newspaper articles, graduation or vendor listings such as class rings, caps and gowns, and graduation announcements. You will need to contact the companies directly. Parents are advised that they cannot select specific items to be included or withheld.
