U-46 consent agenda vote ratifies \$8M in expenses

The Board of Education in School District U-46 approved over \$8 million in expenditure items under its consent agenda at its meeting on Monday, April 15.

The vote was 6-0, board member Jeanette Ward was absent. Ward, who noted her absence was due to a business trip, explained her opposition to one item that was approved.

Two contract renewals with the AVID Center, both to be paid for by the education fund, were approved costing \$55,042 to offer the AVID program and \$46,000 for professional development. Ward wrote she would have voted against the professional development contract because of its divisive and partisan nature of pushing racial and other subgroup divisions.

Part of the training included two sessions titled "Culturally Relevant Teaching," one with a teacher focus and the other a student focus. It describes the training as preparing "to conduct a self-examination and address issues of race, class, gender, sexual orientation, and accountability through a growth mindset. The strand will provide a framework of effective methodologies that validate the culture of all students in the classroom and on the campus....Come ready to engage with colleagues in community-building activities and

critical conversations around race, gender, class, sexual orientation, ability, and language, as well as other culturally relevant topics."

For Ward, such conversations are not appropriate to be had with government workers but rather with family and friends.

"This is the dividing of people by different groups and focusing on what divides us instead of what unites us," Ward wrote. "Conversations about race, gender, class, and sexual orientation are best had in the home, with PARENTS present. AVID, by definition, 'Advancement via INDIVIDUAL Determination,' is supposed to be focused on individuals, not groups."

Ward added: "Conversations about race, gender, class, and sexual orientation are not relevant to encouraging students to apply and succeed in college, unless they are majoring in Community Organizing. The descriptions of these sessions are about advancing leftism and focusing on what divides instead of what unites us and I cannot support them."

Although opposed to the professional development, Ward noted her support of the idea behind AVID.

"What a great idea, to challenge students to take responsibility for their own lives and encourage those who perhaps wouldn't have considered going to college, to go to col-

lege," Ward wrote. "As the first in my family to complete a Bachelor's degree, and then two Masters' degrees, I love encouraging students to achieve what might not have been possible in their families in previous generations."

The largest expenditure item approved under consent was a \$3.3 million proposal (life safety and operations and maintenance funds) with MG Mechanical Contracting, Inc. for an HVAC system replacement at Bartlett's Centennial Elementary School.

A \$3.1 million proposal, from the education fund, over five years with Elgin Community College (ECC) was approved to expand its dual credit program. The district, which will pay the full tuition for students, expects 50 juniors and 50 seniors to take full-time classes at ECC by 2020-2021 as part of an early college program while expecting 1,500 students annually taking dual credit classes at U-46 high schools starting in 2019-2020.

Two parking lot paving proposals were approved, one at Bartlett's Na-

ture Ridge Elementary School costing \$839,239 (operations and maintenance) with A Lamp Concrete Contractors, Inc. and the other at Hanover Park's Parkwood Elementary School costing \$933,817 (operations and maintenance) with Schroeder Asphalt Services, Inc.

The board approved a two-year contract renewal with Micro Focus costing \$220,986 (education fund) for software renewal, a \$101,604 expenditure (education fund) to purchase secondary schools student planners over three years from Global Datebooks, a three-year contract renewal costing \$91,800 (education fund) for maintenance with Tableau Software, Inc., a \$51,050 proposal (education fund) with the College Board for Advanced Placement professional development and a \$29,580 renewal (education fund) of the district's visitor sign-in software with Raptor Technologies.

Also via 6-0 votes, the board approved a renewal of the district's membership with the Illinois High School Association and \$6.3 million in itemized bills.

The proposal stated that the water main had "broken previously in the same area and is in poor condition" and the district made a "temporary" repair which required a "replacement of the water main from outside the building, under the foundation and into the meter room, as the riser cannot be repaired again. If it breaks, operations at that facility will have to cease. The building also requires a reduced pressurization zone (RPZ) and a bypass to be brought up to code."

Board member Sue Kerr asked: "This had broken already and then it broke again, is that what happened?"

Sheila Downs, director of plant operations, said: "It had broken further in the loading dock previously, and this time it broke in the interior of the loading dock.... This repair should hold because we replaced a substantial portion of that line."

Pregame ceremony honors former player

Lindsey Stoen's memory will live on with the Bartlett High School softball program.

Stoen, who would have been a senior this year, passed away last year from a rare juvenile case of ALS, commonly known as Lou Gehrig's disease.

At Bartlett as the Hawks squared off against rival South Elgin on Monday, April 22, Stoen had her No. 17 jersey retired during a pregame ceremony which included releasing 17 balloons.

"Definitely an emotional day," said Bartlett coach Jim Wolfsmith. "It's been an emotional year for our softball community. Lindsey was a really great kid and the number of people that she touched goes far beyond those out here today."

"We were just proud to be a part of that ceremony," said South Elgin coach Brad Reynard. "I know several of our girls knew Lindsey personally, and this was a good experience to be a part of."

ALS is a disorder that leads to muscle weakness and spasms and leads to the loss of voluntary movement, and it usually seen in older males.

According to WebMD.com, 60 percent of those diagnosed with ALS are male and it is "very rare" to be seen before the age of 30.

"Her fight was fierce, she was a true

warrior," said Lindsey's mother Amy Stoen. "It is important to create awareness that ALS is not only an older, male dominated disease, it is affecting our youth as well. We want to be able to thank our family, friends, teachers, coaches, school district, and community for surrounding us all with support and love."

Bartlett's football team held a ceremony at its first home game this year selling T-shirts and wristbands with #LindseyStrong and #FlyHigh raising \$5,500 which was donated to Ann & Robert H. Lurie Children's Hospital's Juvenile ALS and Neuromuscular Research fund.

Lindsey's mom said her daughter donated her cells for research and kept a positive attitude during her battle. Stoen said Lindsey, who was an honor student and also played varsity tennis, showed signs of ALS in the fall of 2017 but wasn't diagnosed until July of 2018 and she passed away shortly after on July 31, 2018.

"She was known for her positive attitude and smile," Stoen said.

Stoen added: "Even during her brief illness and diagnosis she always had a smile on her face and would make all who knew her laugh and feel comforted. She was wise beyond her years."

Baseball: West Aurora evens series with South Elgin

West Aurora senior first baseman Alex Diaz needed a bounce-back game like Tuesday's 7-5, eight-inning win at South Elgin.

So did his Blackhawks.

Upstate Eight Conference leader South Elgin opened 10-plus innings of action by first winning the continuation of Monday's suspended Upstate Eight Conference series opener 6-3.

The Storm led 4-2 in the top of the fifth when play resumed. Garrett Wano's single keyed a 2-run sixth-inning, and South Elgin reliever Grant Baker got Diaz to end it by inducing a line drive to center field with runners on first and second.

The loss dropped the Blackhawks 2 game behind the Storm in the loss column midway through the 27-game UEC schedule.

An 0-for-3 performance with 2 strikeouts for Diaz meant his batting average slipped closer to .200.

West Aurora's No. 9 hitter would find redemption in the nightcap.

Diaz stepped to the plate against reliever Patrick Keaty in the eighth inning with no outs and a runner on third base, thanks to a South Elgin infield error and a passed ball.

Diaz tomahawked a high, first-pitch fastball, for a line-drive single that drove in the winning run and allowed him to exhale.

"That does feel pretty good," Diaz said. "Hopefully, that's a turnaround for me and gets the season going now."

Reliever Kyler Scroggins (4-0) allowed 1 hit and struck out 3 in 2 scoreless innings to earn a win that kept West Aurora (14-5-1, 10-3-1) within a game in the loss column of South Elgin (13-3, 11-2).

"We didn't want to take another loss from South Elgin after the first game," Scroggins said. "We wanted to show we can win, and we want to come back and win the third one."

South Elgin took a 5-4, sixth-inning lead when Cody Gallagher hit a one-out sacrifice fly to score courtesy runner Griffin Allen.

West Aurora forged a 5-5 tie in the seventh. With runners at first and third and one out, South Elgin coach Jim Kating turned to shortstop Keaty to close the ballgame on the mound.

Keaty got what he was looking for: a two-hop double-play ball to shortstop. However, the South Elgin second baseman double-clutched on the relay throw, allowing Adrian Ruiz to reach safely as the tying run scored.

Technically, it wasn't an error for South Elgin. The Storm made 3 of those, leading to 3 unearned runs.

"We couldn't turn a double play," Kating said. "We had opportunities to shut things down and do that but (Diaz) came through. We just came up short.

"We're learning from this. We need this. We need these types of games. This is a testing point to see where we are so far and I like how the kids have been resilient. We just made mistakes and they took advantage of them."

West Aurora starting pitcher Jake Smith lasted 6 innings. He allowed 5 runs (4 earned) on 9 hits and struck out 3 without a walk.

Ben Hetelle, Wano and Baker each had 2 hits for South Elgin, which travels to Aurora for the series finale Wednesday at 4:30 p.m.

Sabres softball blanks Elgin, go 2-1 at tournament

The Streamwood softball team used a 10-run sixth inning to earn an 11-0 Upstate Eight Conference victory over Elgin in a six-inning, 10-run rule game on Tuesday, April 16 at Streamwood.

The Sabres, who scored a run in the first inning, were led by senior Taylyr Crocilla who tossed a three-hit shutout with no walks and 14 strikeouts, and she hit three doubles and drove in two runs at the plate.

"Overall, I am happy with our team's performance," said Streamwood coach Will Shogren. "We had good pitching and defense and were able to score in the first inning which always helps. I'm also happy with the way our team responded late in the game after seeing some good pitching from Elgin."

Shogren added: "Taylyr did really well in the game. Her ball had good velocity and she was able to hit her spots. At the plate, she seemed to see the ball well and jumped on good pitches."

Senior Corrine Angle hit a two-run home run and Tessa Freedman was 2-for-4 with two RBI.

It was Streamwood's senior day as it celebrated five seniors.

"Our seniors have been a big part of any of the success we have had over the past few years," Shogren said. "They are a group of talented players who want to win. I'm happy we have them in this program and it's fun to see them all play together in their final year at Streamwood."

The Sabres went on to go 2-1 at the Larkin Slugfest to finish fifth on Saturday, April 20. Crocilla went 1-1 suffering the loss in the opener, a 9-2 game against Burlington Central, but earning the win in the fifth place game, an 18-5 win over Larkin, and senior Ari-

ana Wolfard was the winner in a 24-0 victory in a four-inning, 15-run rule game against St. Edward.

Freedman was 2-for-3, Crocilla tripled and Hannah Jenig doubled in the Burlington Central loss.

Freedman (3-for-5, triple, double, six RBI), Crocilla (3-for-4, double, three RBI) and senior Laura Dietrich (3-for-5, double, two RBI) all homered against St. Edward while Caitlin Randel (3-for-4) and Maya Mancera tripled and both Gabriella Cardinale (2-for-3, three RBI) and Jenig (2-for-3, two RBI) doubled. Wolfard was 2-for-3 with two RBI.

Dietrich (3-for-5, double, six RBI) homered twice against Larkin. Freedman (3-for-5, double, three RBI), Wolfard (3-for-5, two doubles, RBI), Angle (2-for-5, double, RBI), Jenig (2-for-5, double, RBI) and Crocilla (2-for-5, RBI) all contributed.

The Sabres are now 7-4 overall, 3-2 in the UEC.

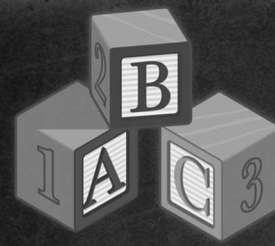

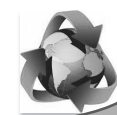

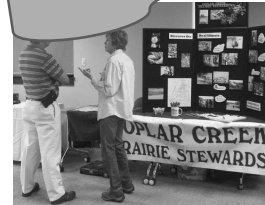

House Republicans to oppose graduated state income tax

According to a Capital News Illinois, Republicans in the Illinois House on Friday, Feb. 22, they are unanimously opposed to Gov. J.B. Pritzker's proposal to overhaul the state's income tax structure, a key element in his plan to close the state's long-term budget imbalance.

Pritzker has called for a constitutional amendment that would allow the state to adopt a graduated income tax, which would levy higher tax rates on income earned above certain thresholds. Currently, Illinois levies a flat 4.95-percent tax on all taxable income.

House Minority Leader Jim Durkin (R-Western Springs) issued a statement saying the GOP caucus would stand united against such a plan.

"Higher taxes won't solve our problems, nor have they ever as history has shown," Durkin said. "Higher taxes only lead to more spending and more government programs. Until our state learns to live within its means, we should not ask for another penny

from Illinois families, workers and businesses."

Both the federal government and most states that have income taxes use a graduated system. But the Illinois Constitution requires that income taxes be levied at a "non-graduated rate."

In his budget address to lawmakers, Pritzker said a graduated tax would generate the revenue needed in future years to pay down the state's unfunded pension obligations, pay off an \$8 billion backlog of unpaid bills and continue funding critical state services.

A constitutional amendment requires passage by a three-fifths supermajority in both chambers of the General Assembly – 73 in the House and 36 in the Senate – followed by voter approval at a statewide general election. That means the soonest a measure could be placed on a ballot would be the November 2020 elections.

Democrats hold 74 seats in the House and 40 seats in the Senate.

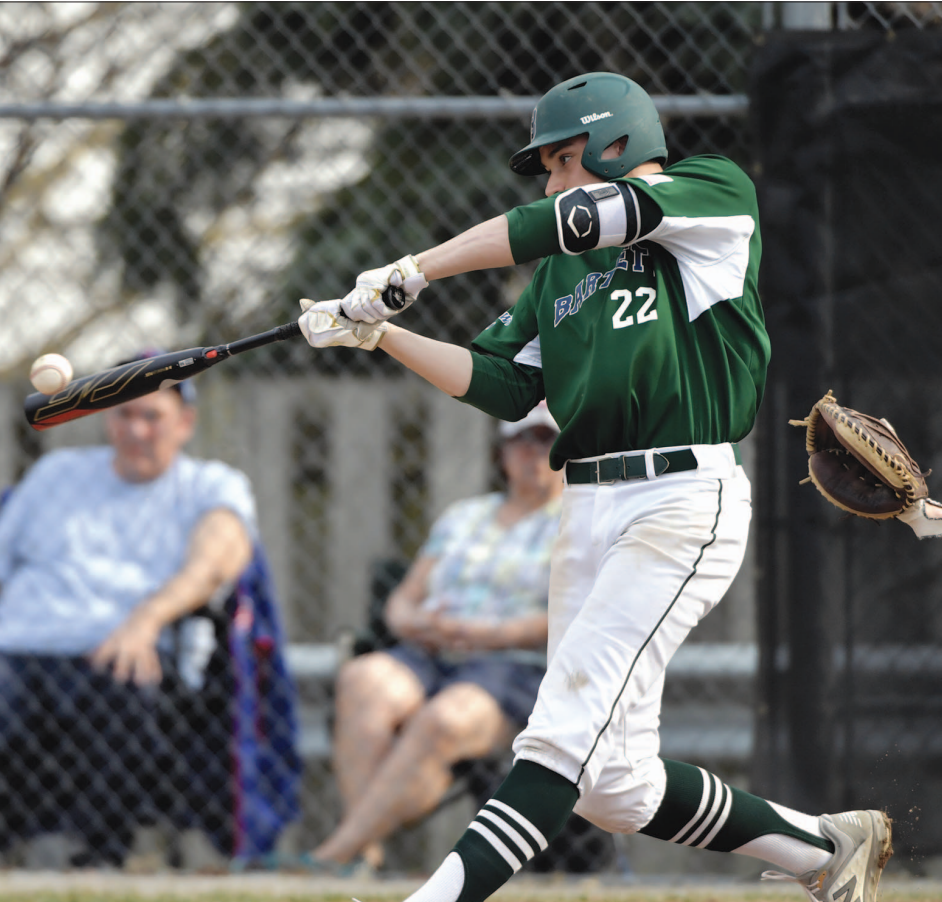

"When you lose that first game of a series, you get

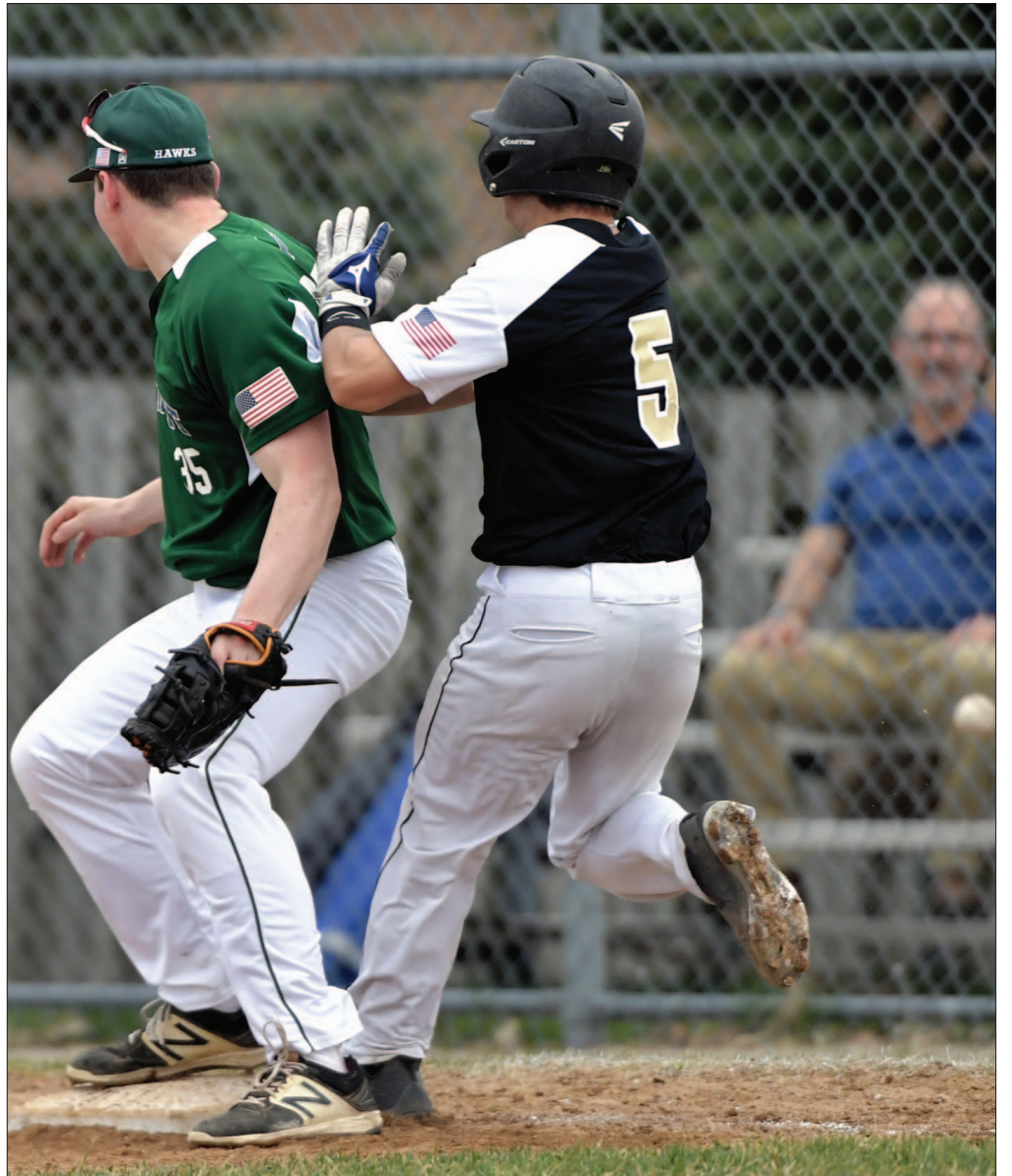
down," Jones said. "But we got that second win which picked us up. It feels pretty good to get the series against Bartlett."

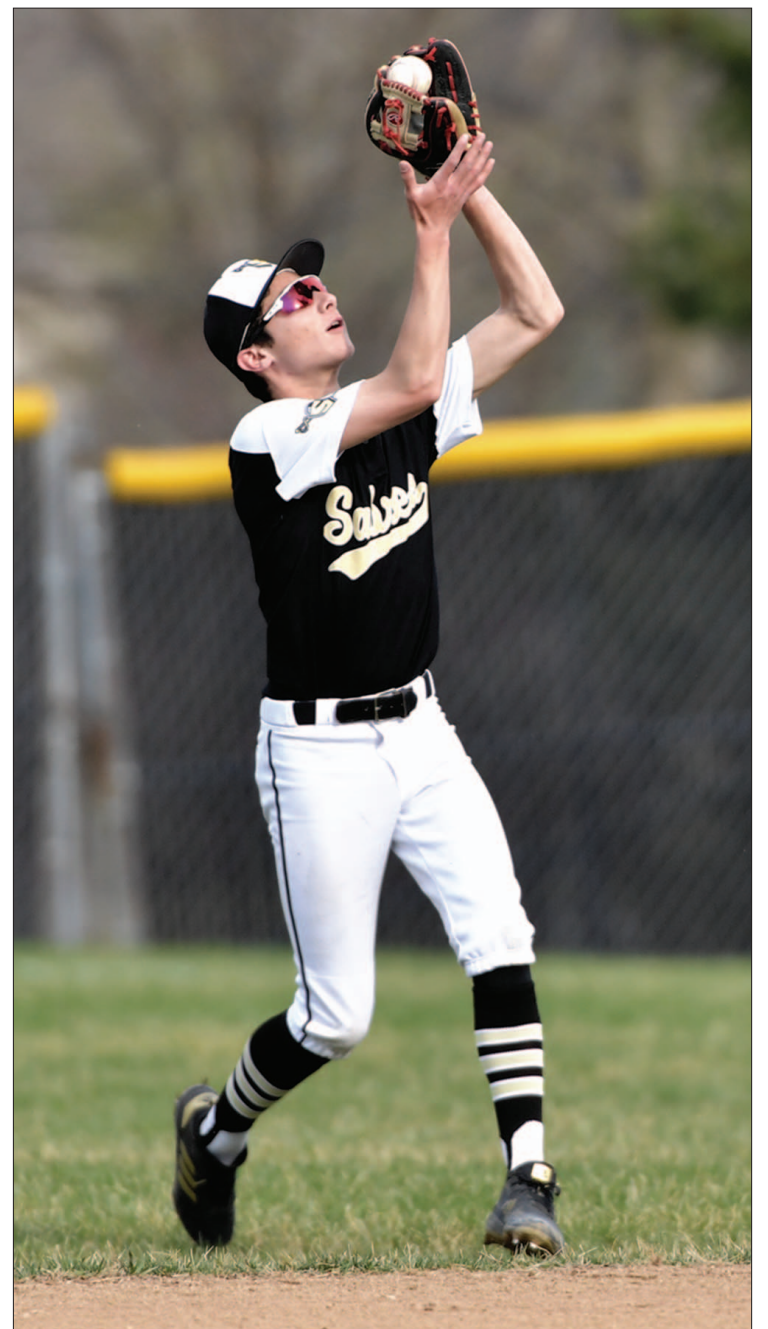
