### Costello offers ideas to new District U-46 board

Phil Costello, an outgoing Board of Education member in School District U-46, has offered his top 10 recommendations for the new board "for what it's worth."

Costello, who did not seek reelection, offered his thoughts on how to better the board's relationship with the public and with the administration, which it is charged with holding accountable, in a blog post.

"Most of these reflect earlier suggestions while others were never going to be seriously contemplated," Costello

Incumbents Sue Kerr and John Devereux, who was appointed to his current seat, and newcomers Eva Porter and Kate Thommes will be seated at a special board meeting on Tuesday, April 30 which will be the final meeting as board members for Costello and Jeanette Ward. Originally, the new board was to be seated at the regular meeting on Monday, May, 6.

Ward, via a social media post, wrote: "This is changed from the originally scheduled May 6th meeting because IL law requires that 'within 28 days after the consolidated election," 'the board shall organize by electing its officers.' Usually the first Tuesday in April (election day) doesn't fall so early, so the 1st Monday in May is normally sufficient. But not this time."

For Costello, his recommendations center mostly around attempting to get more public input, especially taxpayers, and the board taking control over the agenda over the administration's control.

Costello has previously implied that the board's agenda is set by the administration, not by the board.

At a February town hall meeting, Costello said: "(The administration) need(s) a board, a strong board, that acts like the employers that we should be. And it's a give and take, it's not just a one-way street."

Costello recommends that each board member host at least an annual town hall in different areas of the district. He noted that 60 to 75 percent of property tax bills go to fund U-46, and the general taxpayer deserves more of a chance to have a say.

For regularly scheduled board meetings, Costello suggests a change in format that could provide more public

"Change the format of the first Board meeting of the month or at least one per quarter to focus on the public by lengthening the public comment session and holding hearings with state and federal representatives," Costello wrote. "Questions concerning U-46 could be directed at attendees to offer the public insights into public policy by those charged with protecting our interests. Too often, the District insulates itself from the outside politics that directly relates to U-46 residents and taxpayers."

Agendas should be set at least a week in advance, Costello recommends, in order to give more time to digest the material it will be staked to question and vote on. Currently, board members have only a weekend to study the agenda prior to a board meeting.

"Without adequate advance notice, Board members will defer on proper vetting due to limited time and out of respect for staff's investment," Costello wrote.

Costello suggests that the district should promote strengthening the economy locally when possible by giving some preference to local businesses when entering into contracts.

U-46 should better utilize its properties, like buildings and buses, "to better serve the local community and create earned income opportunities with higher utilization," according to

Regarding legal and financial services, Costello suggests the district should seek more competition.

"Most of the financial and legal services are fixed with long-term, unchallenged business relationships that are not subject to competitive conditions," Costello wrote.

The board should focus the district on negotiating for merit based contracts rather than automatic pay raises Costello stated.

"Focus contracts on individual value of services provided measured by supervisors in performance evaluations and demonstrated positive outcomes rather than arbitrary increases based on length of employment," Costello

Costello suggested the board push for more balance within the curriculum.

"Broaden perspective to recognize the historical role and reliance on; capitalists, entrepreneurs and military leaders that contributed to our nation's greatness," Costello wrote. "Too often, the focus is critical on the

achievements of successful individuals who have amassed wealth and ignores the impact on socio-economic engines to benefit society as a whole."

Costello recommends that a disclaimer be added to the district's website on the schedule of staff salary and benefits page because it currently is "misleading" as he noted approximately only 60 percent of compensation is included with many employees not included at all, and "most employees on the list have multiple sources of U-46 compensation beyond the amount listed."

Annually the district should publish a one-page dashboard "of high-level critical success factors (what we need to do) and key performance indicators (targeted, benchmarked performance when we're at our best) that provides the public with clear and objective evidence of return on investment," Costello recommends.

# Village Board approves asphalt materials bid

During the Village Board meeting on Thursday, April 18, trustees voted unanimously to approve a motion authorizing the low bid from Plote Construction, Hoffman Estates, and the secondary low bid from Arrow Road, Mount Prospect, for the supply of asphalt paving materials at a cost of \$732,890.

According to Director of Public Works Matt Mann, these were the only two bidders.

"We'd like to get both in case Plote isn't available one day," said Mann. "Then we can go to the other one."

Mann said asphalt paving material from Plote will cost \$47 per ton for surface, \$44 per ton for base and \$47 per ton for level binders. The price from Arrow is \$48 per ton for surface, \$44 per ton for base and \$46 per ton **■** for level binders.

"We anticipate about using 15 tons of asphalt this year," Mann said.

According to Mann, the 2019 street

program budget includes the in-house resurfacing of the Streamwood Green, Suncrest North, Oaks of Hidden Glen and Sussex Square subdivisions. It also includes Dato Drive, Debbie Lane and Valley Lane. This hot mix asphalt supply is required for the in-house resurfacing.

According to Mann, the bids were adjusted based on the distance to each asphalt plant, however, Plote is the low bidder even without the adjust-

Mann said the price for the estimated supplies from both Plote and Arrow with the adjustment is \$771,124.

"We pay the bid price not the adjusted price," Mann said.

The adjustment is used to account for the cost of using the village's trucks and manpower to pick up the asphalt at the plant, according to Mann. Plote's plant is in Bartlett and Arrow's is in Algonquin.

According to Mann, the engineer's

estimate was \$716,020.



# Hawks walk away with 11-3 win over Wildcats

The Bartlett baseball team built a lead and took advantage of walks late to run away with an 11-3 win over West Chicago in Upstate Eight Conference play on Wednesday, April 24 at Bartlett.

Hawks coach Devin Rosen said his team was "not overly anxious" at the plate which helped them take the lead for good early. Michael Vaca (2-for-2, three RBI) hit a solo home run for a 1-0 lead in the second inning, and Bartlett used a three-run third to break a 1-1 tie behind RBI singles from Vaca and Frankie Gherardi.

West Chicago pulled within a run, 4-3, but the Hawks took advantage of eight walks in the sixth inning to score seven runs. Vaca, Matt Lewandowski (2-for-3), Geno Frieri (double), Sam Mallinas, Matt Angelone, Ryan Nelson and Max Lewis all had an RBI in the frame.

Nathan Euliano went the distance on the mound allowing one earned run off of three hits and three walks, and he struck out six. Bartlett's defense committed one error allowing two unearned runs, but it was sharp for the most part after an error prone

week the previous week, including a nine-error game.

"It started with our pitcher," Rosen said. "Nate did a great job throwing strikes. That right there sets the right tone, and it makes the defense be on their toes and ready each pitch."

Bartlett will have a chance at a three-game series sweep when play resumes from two suspended games on Thursday, May 2 at West Chicago.

In Game 1 of the series, which was called due to lightning in the fourth inning, saw the Hawks leading 6-2 on Monday, April 22 at Bartlett. Blake Oliver (2-for-2, double, four RBI) and Nelson have both homered, Mallinas and Vaca have doubled and Nathan Gargano is the current pitcher of

"I think knowing how we handled them today and where we are in the other games, we're in good position," Rosen said. "As long as we don't take our foot off the accelerator, we're in a good spot to finish them off."

Bartlett, now 7-7-1 overall and 5-7 in the UEC, added a 10-4 nonconference win over Conant on Thursday, April 25 at Bartlett. Vaca (3-for-4, double, two RBI), Angelone (3-for-4), Vesta (2-for-4, double, three RBI) and Lewis (2-for-3) led the offense while Nick Kantzavelos earned the win and Danny Cahill a save on the mound.

The Sabres opened the week with a



The city of Elgin's efforts to boost the number of women holding government leadership roles will be recognized by the YWCA Elgin at its annual awards luncheon next week.

According to the YWCA, 69 of the city's 154 managerial positions — about 45% — are held by women, a fact that's deserving of the YWCA's Corporate Award, which will be presented at the Leaders Luncheon Awards being held May 9, at the Seville in Streamwood, officials said.

The award will recognize the city for recruiting and retaining females in leadership roles. Among the women now heading departments who were promoted from within the government ranks are police Chief Ana Lalley, Chief Financial Officer Debra Nawrocki, Human Resources Director Gail Cohen, and Parks and Recreation Department Director Maria Cumpata. Assistant City Manager Laura Valdez-Wilson was also promoted internally and the majority of the city manager's staff is female.

"Women play a major role in carrying out the policies set by Elgin's city council," luncheon chair Rebecca Hardekopf said in the release.

YWCA president Julia McClendon said the city is impressive in their dedication to advancing women within the organization.

"There is a pathway," McClendon said. "You never see pathways for women to get ahead once you get to a certain level. They went beyond just women advancing in their careers, they are advancing women into leadership roles."

City Councilwoman Rose Martinez said the city has made significant inroads in the last five years, but it's not just because the hiring and promotion of women has been a priority. It's because the city has made good hires and the employees have been deserving of the promotions, regardless of their sex, she said.

"To me, it's more about the quality of the individual," Martinez said. "And I think what we have right now is great quality, people who have been there for many years."

YWCA officials also recognized city efforts to bring more women into the public safety and public works departments, which traditionally have been overwhelmingly male. In addition to the chief, two sergeants and 14 officers in the police department are women.

Elgin's public works department has five engineers, three of whom are female.

The event's keynote speaker is Jane Blain Gilbertson, president and CEO of Blain's Farm and Fleet.

### Duo win gold in global contest

Junior cheerleaders help lead U.S. to top spot in competition **By: Rafael Guerrero**

Two juniors at South Elgin High School are world champions following their team's performance at an international cheerleading competition over the weekend.

Earlier in the year, Thomas Justin "TJ" Ramos and Tristan Cruz were selected from a pool of dozens to represent the U.S. National Junior Coed Cheerleading Team at the International Cheer Union World Championships. The two were among a group of 28 teens — most of them from Illinois — who helped the U.S. team take gold in their respective competition in Orlando, Fla.

"It was really cool because not many get to experience this," said Ramos, 17. "Our coaches were telling us how lucky we were. There are thousands of cheerleaders around the world that are dying for the position we found ourselves in."

The U.S. junior coed team defeated challengers from other countries, including runners-up Norway and Finland. More than 70 countries participated in the multi-event International Cheer Union World Championships. The International Cheer Union is the governing body for cheerleading, recognized in 2016 by the International Olympic Committee.

"Being picked to be on this team is an unmatched experience," said Cruz, 16.

The victory continues the years-long success and friendship of Ramos and Cruz, who have known each other since kindergarten. For the majority of those years, the two were gymnasts.

This school year, the two moved away from gymnastics to cheerleading.

They credit South Elgin varsity cheerleading head coach Savannah Bennett for convincing them to change sports. Bennett coached Ramos' younger sister and she would often share videos of her brother's gymnast skills with Bennett.

"She helped me get to where I am today," Ramos said about his coach.

Bennett said she was proud to see the boys compete on an international scale. She was in attendance at this weekend's competition, tears welling up in her eyes as they competed.

She said the two stand out for multiple reasons. Ramos and Cruz constantly work to improve their skills, and their mindset prevents them from believing their performances are ever good enough. The two, however, are always positive, always encouraging their teammates, Bennett added.

"Both are natural leaders. When they speak, people listen — very genuine people," she said.

In preparation for last weekend's competition, both Cruz and Ramos practiced at least three times a week throughout much of February, March and April. The two were selected for the U.S. junior coed team in February. At an April school board meeting, board members recognized the duo.

Both plan to do cheerleading again for their senior years in the fall. The two value being on a team versus the more individualistic approach to gymnastics.

"You live and die as a team. I just like being a part of a team," said Ramos.

"Competitions are my favorite," Cruz said. "Even if I come in nervous, I want to go out there and show what I can do."

It's a big two weeks for the Bartlett volleyball team as the Hawks head into the homestretch with a shot at the Upstate Eight Conference title.

Bartlett took a big step in the right direction by handling Glenbard East, 25-14, 25-16, Tuesday in Bartlett. "We set over way too many free balls. Our serve and serve-receive broke down and we weren't able to get too much going offensively to get them out-of-system," she said. "They did a great job of keeping the momentum on their side. They outplayed us, and it was fun to watch them play tonight."

Carter Burzlaff, the 6-5 setter who is about to sign a letter of intent with Lewis University, was the Hawks' Swiss army knife. He had 4 aces, 3 kills and assisted on 22 more points.

Garrett Jurina and Josh Kramp added 4 kills apiece for the Hawks while Martin Radomski led the defense with 4 digs.

Kurt Csech was a force for Glenbard East, smacking 7 kills, including 5 in the early part of the second set to keep the Rams in it. Kameron Cummuta added 3 kills for the visitors.

Set 1 was also a back-and-forth affair early. Bartlett led just 7-6 at one point. Back-to-back aces by Burzlaff made it 14-8 and the Hawks, while not putting together any big runs, slowly pulled away.





off Keaty to score.


"It came down to who made mistakes in that one," Kating said. "We made a couple crucial mistakes, and they took advantage of them."



"There's no doubt I was happy with the way we've played today," Wolfsmith said. "Vanessa pitched well and the defense made some great plays."



Gabriella Cardinale added a 2-for-4 performance with a double.



The Sabres split a pair of UEC games to open the week. Streamwood is now 9-5 overall, 5-3 in the UEC.


