### **Dist. 300 leader earns top honors in Kane County**

Elgin, West Dundee teachers also win educator award

The superintendent for School District 300 and teachers for Elgin and West Dundee schools were among the big winners of Kane County Regional Office of Education's awards.

Fred Heid, superintendent of Algonquin-based District 300, was named Kane County School Administrator of the Year.

School District U46 teacher Mary Fulin won Elementary School Teacher of the Year, Elgin Academy teacher Peggy Veltri won Private/Parochial Teacher of the Year, and District 300's Beth Harner won Middle School Teacher of the Year. The awards were presented Friday night.

Heid is in his fourth year overseeing District 300 and has spent 19 years in education.

"At the end of the day, what matters most is that relationship and interaction between an adult and a child, and that's what we're here to support," Heid said in a news release on the award winners.

Fulin is a second-grade teacher at Otter Creek Elementary School in Elgin. She's been teaching for 32 years.

"We all know that students come in with different social and emotional needs, so I make it a part of our curriculum," Fullin said in the release. "I want to teach them how to behave in different situations depending on the circumstances."

Veltri, a 15-year classroom veteran, teaches social studies and English at Elgin Academy.

"I like to give the kids a lot of opportunities to write for different audiences," she said in the release. "If my students can communicate their ideas clearly to others, that can make a huge difference in the rest of their lives."

Harner is a special education teacher at Dundee Middle School in West Dundee. She has been teaching for 22 years.

"I see a real need for kids to be able to make the transition from life inside of a school to being a contributing member of society," she said.

## U46 honors service of former board member

Traci O'Neal Ellis plans to pursue national activism

Former **School District U46** board member Traci O'Neal Ellis returned to the district board room Monday night — this time as a resident.

Two weeks after resigning her school board seat, Ellis was honored by the district and board during the Monday meeting. She was presented with a “recognition of service” plaque for her seven years on the board, a tradition for members who have resigned or whose terms have ended.

“You all have just poured out love and support for me these last couple of weeks and I am so grateful,” Ellis said at the meeting Monday. “I got more than I gave, and it was my absolute honor to serve this district, to serve the students, to serve the administration, to serve the teachers, and to serve these kids.”

Ellis — who plans to pursue a larger social activism role on a national level — thanked most of the board members and said she was happy to be leaving the district “in good hands.” She noticeably left out the names of board members Jeanette Ward and Phil Costello, with whom she frequently sparred while on the board.

“We appreciate and thank you for your service for seven years from not only us, but from students and staff and everyone in U46,” board President Donna Smith told Ellis.

In addition to the plaque, Ellis also received the nameplate that identified her when she was part of the board.

It is expected Ellis’ successor will be named by the board at its June 4 meeting. U46 chief legal officer Miguel Rodriguez said seven people have submitted applications to fill the vacancy ahead of a Wednesday afternoon deadline.

## **Members aim to fill empty seat**

Timetable set up to fill O'Neal Ellis opening in June

**School District U46** board members expect to choose Traci O'Neal Ellis' replacement at the board's June 4 meeting.

With a Wednesday afternoon deadline for residents to submit applications for the open position — and seven people already expressing an interest in the job — the board needs time to vet and interview candidates before making a selection.

Board members said they would interview all seven candidates on May 17 and 18, with each person receiving 30 minutes.

And unlike the last time the U46 board appointed someone to a vacant seat, the current board is inclined to hold the interviews in an open session.

"We campaign as board members (in public), so interviews for board candidates could be held in the open also," board President Donna Smith said.

While the interviews would be public, vetting and reviewing the applications will happen behind closed doors Monday, board members decided.

The deadline to choose O'Neal Ellis' successor is June 7. O'Neal Ellis stepped down April 23, and state law dictates the appointment occur within 45 days of the resignation.

"I understand that we're all busy, but we also need to put the effort into this so we make sure we get the right candidate," board member Melissa Owens said.

## **U46 board agrees to buy building**

Will serve as new family service site, plus bus parking

**School District U46** will buy the former Sherman Health building on East Chicago Street in Elgin after board members unanimously approved the \$4 million proposal.

The long-vacant building will house a family welcome center for new students and a depot for the district's smaller school buses.

Board members had no opposition to the proposal, voting 6-0 in favor.

It was one of the board's first votes without a seventh board member. Traci O'Neal Ellis resigned her seat last month, and it will remain vacant through early June.

As a family welcome center, U46's language testing, registration, early childhood screenings and other services would be consolidated into one location.

Officials said the purchase also will save the district about \$1 million annually because it will no longer have to provide a shuttle service for its small school bus drivers to the main school bus depot on Shales Parkway.

The 95,512-square-foot building has been vacant for years, but U46 and nearby auto dealers have leased out part of the 10-acre parking lot over the years.

The site once was considered as a possible indoor amusement park site, but the plans fell through.

## **U46 board to interview seven candidates to fill its vacancy**

Seven candidates have applied so far to fill a vacancy on the Elgin Area School District U-46 school board stemming from board member Traci O'Neal Ellis' resignation last month.

Ellis, an Elgin attorney and executive director of human resources for Aurora-based Illinois Mathematics and Science Academy, stepped down after serving seven years on the board to advocate for educational equity and criminal justice reform with a Washington, D.C.-based national think tank.

Wednesday is the deadline for applications to fill her seat.

Illinois School Code allows school districts 45 days from a trustee's resignation to fill a school board vacancy. The deadline for U-46 to appoint a candidate is June 7, board President Donna Smith said Monday.

The school board will review applications in closed session May 14 at South Elgin High School. The board then will interview all candidates one-on-one for 30 minutes each in public during special meetings May 17 and 18 before possibly appointing someone at either the May 21 or June 4 regular board meetings, officials said.

The last time the school board had to appoint a board member there were eight candidates to fill the seat vacated by Frank Napolitano in March of 2014. The board appointed Linda Campos-Moreira of Elgin to serve until the next election in April 2015.

Whoever is appointed to Ellis' seat will serve the remainder of her term expiring next April.

## **Softball: Fast start lifts Larkin over Elgin**

After three years at shortstop, Haley Bohne moved behind the plate for her senior year at Larkin.

The Royals needed a veteran to work with their young pitchers. Coach Anne Vogt knew just who to turn to.

"With some inexperienced pitchers you have to have someone back there and she's really stepped up and done a nice job," Vogt said. "I know it's not her favorite job to have ice on her knees after every game but she's really doing a nice job making runners think twice. And she's got a great relationship with both pitchers."

It was Kiara Villa's turn Tuesday, and the junior went the distance in an 11-6 win over Elgin.

Larkin improved to 5-15 and 3-9 in the Upstate Eight River while Elgin remained winless.

Bohne also made a big impact at the plate. She hit a 2-run home run in her first at-bat, then walked her final three times up.

The last two times she walked, Bohne stole second and third base. She scored on all four of her at-bats.

"If they intentionally walk me we're going to make them pay," said Bohne, a two-sport standout who will play softball and basketball next year at ECC.

Bohne's homer was her seventh of the season and scored Liz Bowman who had walked for a quick 2-0 lead.

Emma Carrero doubled and scored on a groundout by Sandra Gomez Herrera to bring the Maroons within 2-1 before Larkin scored 7 times in the bottom of the second for a 9-1 lead.

The Royals capitalized on 4 walks in the inning. Kathy Garcia provided the big blow with a 3-run double.

"In that second inning I feel everything that could go wrong did go wrong," Elgin coach Jenna Szabo said.

The Maroons scored twice in the third and fifth innings to get within 10-6.

"We were chipping away," Szabo said. "I told them it can be 10-0 and we can go home in 5 or we can make this a game. They didn't give up."

Elgin starter Abby Sensor struck out 12 and held Larkin to 2 runs over the final 4 innings. Both of those runs came when the Maroons intentionally walked Bohne leading off an inning, she stole second and third base, and scored -- first on Katie Turner's single and then on Abbie Stout's ground ball.

"We said if you are going to put her on she's got a triple in two pitches," Vogt said. "Our team did a great job behind her."

Villa helped herself with a 2-run single in the second and another hit in the sixth. Bowman and Turner also had 2 hits for Larkin.

"We didn't play the best defense behind her (Villa) and that's always hard on a pitcher but she kept her head high," Vogt said. "She's a workhorse."

## **Elgin blanks Larkin in UEC River action**

Elgin always gets a lift from beating its crosstown rival, but with girls soccer regionals starting next week, the Maroons' win Thursday gives them some extra momentum heading into the postseason.

Margaretha Troyke and Brittany Dazzo scored for the Maroons while Joana Mercado posted the shutout in goal as Elgin downed Larkin, 2-0, in an Upstate Eight River matchup at Memorial Field Tuesday night.

It was officially a Larkin home game.

"Larkin's always a great game," said Elgin coach Alicia Knoll. "It's good competition. They're a good team, we're a good team, so it's just fun to play a really strong game."

The Maroons' defense fueled the effort.

"The defense really did a good job of shutting them down, bringing that enthusiasm, making the smart play," Knoll said.

Elgin made a push early in the game, putting 4 shots on goal in the opening minutes. Larkin counterattacked midway through the half, but neither team could find the back of the net.

Troyke finally got the Maroons (10-7, 2-4) on the scoreboard in the 35th minute. Elgin's keeper stopped an initial attempt but bobbled the ball and Troyke found herself alone in front of an open net. She deked out a defender and put it in.

"Once I got it out of her hands after she bobbled it, I thought the defender was going to block it, but I just took my shot and it went in," said Troyka.

Dazzo provided some much-needed insurance in the second half. Her free kick from close range was placed perfectly, just over the outstretched hand of Larkin keeper Lluviana Carmona. It ticked off the crossbar and barely passed the goal line.

"Larkin's a really great team and they were still in the game at halftime," Dazzo said. "So we really needed to capitalize on that one shot and we were able to."

While Elgin arguably got a bit lucky on both goals, Larkin coach Ken Hall said the Maroons made their own breaks.

"They were more aggressive during the entire game, and when you're the aggressive team, you're going to get the breaks," said Hall. "And I think that's basically summing up the game tonight

## **Hamer, St. Charles North keep rolling, down Larkin**

Miami of Ohio recruited St. Charles North senior Steven Hamer as a two-way baseball player because of performances like Tuesday's 11-1, five-inning victory against visiting Larkin.

On the mound, the left-hander struck out 8 to raise his season total to 43 and did not issue a walk, freezing that number at 9. He improved to 4-0 and lowered his earned run average to 1.15 in 25 innings.

Hamer was equally tough on the Royals batting cleanup. He went 2-for-4 with 2 doubles to the wall and drove in 2 runs to lead a 9-hit attack in the Upstate Eight River win.

What will the Redhawks ask of Hamer when he joins them next season?

"They'll probably have me as a pitcher. I don't know yet," he said. "It'll be interesting to see what we do."

St. Charles North coach Todd Genke says Miami is getting a ballplayer either way.

"I just love the way he competes when he pitches," the North Stars' 14th-year coach said. "We know he's going to give us a great, quality start. Offensively, he's hitting in the four-hole for a reason. He's a special player and he makes us tick."

Larkin (7-13, 5-12) jumped to a first-inning lead. Craig Reuter led off with a double down the right-field line and later scored from third when North's third baseman could not handle a hard groundball off the bat of Gunnar Boley.

The Larkin lead did not last long. St. Charles North (19-2, 13-1) responded with a 4-run first inning against Larkin junior left-hander Max Anderson. The rally included 3 hits, including a run-scoring knock by Erik Larson, but the Royals unintentionally aided the rally with 2 infield errors and 2 walks.

The North Stars struck for 6 more runs in the second to take a 10-1 lead. Anderson walked Patrick Bellock to start the inning and Larkin's third error opened the floodgates. Anderson was charged with 10 runs, 2 of which were earned.

"It was kind of a mix of a couple of errors, they get a hit or two, a walk, a hit by pitch," Larkin coach Matt Esterino said. "Max did not have his best stuff, but against quality teams in our conference you have to play your best ball and that wasn't our best."

Junior Zach Hubbard relieved Anderson with two outs in the second inning, trailing 10-1, and kept the score right there. The right-hander limited North to a lone hit in  $2\frac{1}{3}$  innings. Hubbard did not allow a run until Bobby Rosengarten ended the game with a run-scoring, one-out single in the fifth inning to invoke the 10-run rule.

St. Charles North's Sean Nemetz drove in 3 runs without a hit and leadoff man Ryan Thiesse doubled and drove in a pair.

Reuter, Boley and Andy Bonnot had the only hits for Larkin, which has lost 4 straight since a 7-1 home win against St. Charles East on April 25.

## Village Board approves new towing proposal

At the Village Board meeting on Thursday, May 3, trustees voted unanimously to approve a resolution to authorize comprehensive towing services with Artie's Towing, Inc., Elgin.

According to Chief of Police Ed Valente, the current towing contract with Bloomingdale Towing expires on May 20. The contract is for a term of two years with one additional

two-year extension permissible by agreement of both parties.

"The police department is charged with the responsibility for managing towing services for all village needs," said Valente.

According to Valente, activities covered under the towing services contract include all police-related tows for abandoned vehicles, service and maintenance towing, impounds, and snow and tow opera-

tions.

Proposals were solicited from vendors to provide the most cost-effective services. Artie's Towing, Inc., was the sole company to submit a proposal, Valente added.

"Artie's Towing has been inspected by police department staff and was found to meet the requirements," Valente said. "Additionally, Artie's has provided exceptional service to Streamwood in the past."

Valente added that Artie's Towing is open 24 hours each day, seven days a week and does not close for holidays. There are 13 trucks available for towing and there is no cost to the village as all towing charges are paid for by vehicle owners. The proposed contract cost is \$75 per tow and \$30 per day for storage.

"This is a similar to our policy we had with Bloomingdale," Valente said.

## Transparent step taken by District U-46 Board

The Board of Education in School District U-46 approved making public closed session meeting minutes from about a decade ago at its meeting on Tuesday, April 23. The vote was 6-0, board member Sue Kerr was absent.

The U-46 board held 70 total closed session meetings over two years and released minutes from 34 meetings in 2007 and 36 from 2008. Portions of the minutes have been "redacted and agreed to by the Board of Education" according to the agenda.

Donna Smith, the board's president, is the only current board member on the board in 2007 and 2008.

For board member Jeanette Ward, this was a small win as she has attempted to make the board more

transparent to the public since taking her seat in 2015. Board member Phil Costello has consistently supported Ward's efforts for greater transparency.

Ward thanked staff including Miguel Rodriguez, chief legal officer, for reviewing the minutes.

"I wanted to thank especially Miguel, and also administration for working so hard to review these minutes and make recommendations for what can be released to the public," Ward said. "I'm very glad to see us taking this step."

In February, Costello and Ward voted against the destruction of closed session recordings from 14 meetings in 2016. Although against the destruction of tapes, Ward said at the time "we're starting to have discussions as a board about this"

which she clarified with *The Examiner* that in closed session that evening was the first time the board discussed possibly releasing any previous closed session discussions to the public.

In only her second meeting on the board in 2015, Ward asked to listen to previous closed session record-

ings but had her civil rights violated by the board's majority, as clarified later by the Illinois General Assembly with a law which forced the U-46 board to change its policy and practices. Since then, Ward has been in the center of several battles to create more transparency in the district.

## Extensive damage left in wake of town home unit fire

According to the Streamwood Fire Department, on Tuesday, May 1, at 11:51 p.m., fire crews responded to a report of a fire in the 200 block of Teak Lane.

Upon arrival, Battalion 9 reported heavy fire coming from the roof of a two-story, four-unit town home. The first-arriving fire companies confirmed that the residents had already evacuated the building but conducted a search as a precaution. The fire was brought under control using two hand

lines. Adjacent housing units were checked, but there was no fire extension. Operations were hampered by strong wind conditions.

The two occupants in the unit were awakened by smoke alarms and were able to evacuate safely. One firefighter sustained a non-life-threatening injury.

The cause of the fire has not yet been determined and is under investigation. Damage has been estimated at \$150,000.

The Board of Education in School District U-46 approved of the CEO's Student Advisory Council's pick for the next student advisor to the board at its meeting on Monday, April 23. Jackson Teetor was selected as the next student advisor and Isabella Cwik as his alternate, both currently juniors at Larkin High School. Teetor will be replacing outgoing student advisor Casey Pearce, a senior at Bartlett High School. South Elgin High School student Mahima Dave and Larkin student Alexis Pluss, both on the CEO's Student Advisory Council, described the process for selecting candidates. Pluss said the process was "completely student driven." She said high school principals ask their own student advisory committees to submit candidates from their schools, and ultimately eight candidates were forwarded on to the CEO's Student Advisory Council with two each from Bartlett, Larkin, South Elgin and Streamwood high schools. Of Teetor and Cwik, Dave said: "Ei-

ther of them would be an excellent addition to the board." Dave said of Teetor that he was "very passionate for Larkin and School District U-46 but expresses his deep passion for social justice, the power of education and the right to express ones voice politically." In an essay written for the selection process, Teetor said his two most important issues are "arts in all levels of education" and college readiness. Teetor said at the meeting he was "super excited to be joining the board" and "I like to have my voice heard, and I like to have everyone's voice heard." Pluss said of Cwik that she was an "intelligent and hard working student" and "uniquely gifted to not only serve but also lead." Cwik said she was "truly filled with so much gratitude" and it was "such an important and pivotal moment" in her life. "I love this district and what it stands for with diversity, and being in front of you is truly a humbling moment," Cwik said.

# Transparent step taken by District U-46 Board

The Board of Education in School District U-46 approved making public closed session meeting minutes from about a decade ago at its meeting on Tuesday, April 23. The vote was 6-0, board member Sue Kerr was absent.

The U-46 board held 70 total closed session meetings over two years and released minutes from 34 meetings in 2007 and 36 from 2008. Portions of the minutes have been “redacted and agreed to by the Board of Education” according to the agenda.

Donna Smith, the board’s president, is the only current board member on the board in 2007 and 2008.

For board member Jeanette Ward, this was a small win as she has attempted to make the board more transparent to the public since taking her seat in 2015. Board member Phil Costello has consistently supported Ward’s efforts for greater transparency.

Ward thanked staff including Miguel Rodriguez, chief legal officer, for reviewing the minutes.

“I wanted to thank especially Miguel,

and also administration for working so hard to review these minutes and make recommendations for what can be released to the public,” Ward said. “I’m very glad to see us taking this step.”

In February, Costello and Ward voted against the destruction of closed session recordings from 14 meetings in 2016. Although against the destruction of tapes, Ward said at the time “we’re starting to have discussions as a board about this” which she clarified with *The Examiner* that in closed session that evening was the first time the board discussed possibly releasing any previous closed session discussions to the public.

In only her second meeting on the board in 2015, Ward asked to listen to previous closed session recordings but had her civil rights violated by the board’s majority, as clarified later by the Illinois General Assembly with a law which forced the U-46 board to change its policy and practices. Since then, Ward has been in the center of several battles to create more transparency in the district.

North is now 11-7 overall, 7-4 in the UEC.



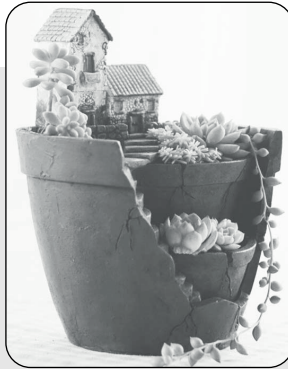

## No license need to collect mushrooms

No license is required for mushroom collecting in Illinois, but mushroom collectors always need landowner permission. On public sites, mushroom collectors must adhere to approved regulations and hours. Collection of mushrooms is allowed in many IDNR state parks, fish and wildlife, and other recreation areas, but it is prohibited in any area designated as a dedicated nature preserve.

Areas under the jurisdiction of the IDNR that offer spring turkey hunting are not open to mushroom collecting until after 1 p.m. daily during turkey season to ensure the safety of all site visitors. Mushroom collectors should call ahead to the IDNR site they intend to visit to learn of any site-specific regulations.

# Transparent step taken by District U-46 Board

The Board of Education in School District U-46 approved making public closed session meeting minutes from about a decade ago at its meeting on Tuesday, April 23. The vote was 6-0, board member Sue Kerr was absent.

The U-46 board held 70 total closed session meetings over two years and released minutes from 34 meetings in 2007 and 36 from 2008. Portions of the minutes have been “redacted and agreed to by the Board of Education” according to the agenda.

Donna Smith, the board’s president, is the only current board member on the board in 2007 and 2008.

For board member Jeanette Ward, this was a small win as she has attempted to make the board more transparent to the public since taking her seat in 2015. Board member Phil Costello has consistently supported Ward’s efforts for greater transparency.

Ward thanked staff including Miguel Rodriguez, chief legal officer, for reviewing the minutes.

“I wanted to thank especially Miguel,

and also administration for working so hard to review these minutes and make recommendations for what can be released to the public,” Ward said. “I’m very glad to see us taking this step.”

In February, Costello and Ward voted against the destruction of closed session recordings from 14 meetings in 2016. Although against the destruction of tapes, Ward said at the time “we’re starting to have discussions as a board about this” which she clarified with *The Examiner* that in closed session that evening was the first time the board discussed possibly releasing any previous closed session discussions to the public.

In only her second meeting on the board in 2015, Ward asked to listen to previous closed session recordings but had her civil rights violated by the board’s majority, as clarified later by the Illinois General Assembly with a law which forced the U-46 board to change its policy and practices. Since then, Ward has been in the center of several battles to create more transparency in the district.

# Its calf birthing season for the bison heard at Fermilab

Fermilab offers several annual traditions for its neighbors, from the Family Open House to the STEM Career Expo. But none are quite as anticipated as the birth of the year’s first baby bison.

On April 18, baby bison season officially began. The first calf of the year was born in the early morning hours, with a second appearing before noon. The first two baby bison calves are healthy and keeping up with their mothers, walking and nursing.

Fermilab is expecting between 10 and 14 new calves this spring, and all of the neighbors are welcome to come on site to visit with and photograph the newborns. (They are always a hit with young children.) The Fermilab site is open every day from 8 a.m. to 8 p.m., and admission is free. You’ll need a valid photo ID to enter the site.

Fermilab’s first director, Robert Wilson, established the bison herd in 1969 as a symbol of the history of the Midwestern prairie and the laboratory’s pioneering research at the frontiers of particle physics. The herd remains a major attraction for families and wildlife enthusiasts.

And thanks to the science of genetic testing, Fermilab’s ecologist con-

firmed that the laboratory’s herd shows no evidence of cattle gene mixing. Farmers during the early settlement era would breed bison with cattle in an attempt to create more tame bison or more hardy cattle.

A herd of bison is a natural fit for a natural laboratory. Fermilab hosts nearly 1,000 acres of reconstructed tallgrass prairie, as well as remnant oak savannas, marshes and forests.

While at the Fermilab site to see the bison, visitors can also learn more about the ecological efforts by hiking the Interpretive Prairie Trail, a half-mile-long trail located near the Pine Street entrance in Batavia. The Lederman Science Center also offers exhibits on the prairie and hands-on physics displays. The Lederman Center hours are Monday through Friday from 8:30 a.m. to 4:30 p.m. and Saturdays from 9 a.m. to 3 p.m. And the 15th floor of Wilson Hall is open to the public Monday through Friday from 8 a.m. to 4:30 p.m. and Saturdays and Sundays from 9 a.m. to 3 p.m.

The South Elgin baseball team rallied for a 7-6 win over Glenbard East in Upstate Eight Conference play on Tuesday, May 1 at South Elgin.

Trailing 6-4, the Storm scored three times in the bottom of the seventh inning giving Nicholas Poblocki the win. Nate Gomez (2-for-4, four RBI) and Patrick Keaty (RBI) both homered in the game, and both Zachery Saunders (3-for-3) and Grant Baker (two RBI) doubled in the effort.

The Storm were coming off a 15-13 loss in an UEC slugfest against St. Charles East on Monday, April 30 at South Elgin.

The wind was blowing out leading to five total home runs, Keaty (2-for-3, RBI) and Austin Doty (2-for-5, two RBI) each clearing the fence for the Storm, and the game featured a South Elgin rally to keep the game going.

Trailing 11-0 and facing the 10-run rule in the bottom of the

fifth inning, the Storm plated three to keep the game alive.

“On a day like that, the wind’s blowing out, you never know,” said South Elgin assistant coach Ben Erickson.

The Saints went up 13-3 in the top of the sixth inning to see the Storm score five, and East made it 15-8 when South Elgin again plated five in the bottom of the seventh and eventually brought the tying run to the plate.

“I’m happy our kids battled back,” Erickson said. “They had the opportunity to put themselves ahead, but you can’t put yourself in that predicament right off the bat.”

Logan Romasanta (2-for-5, two doubles, RBI), Gomez (2-for-5, double, two RBI), Nathan Smith (2-for-3, RBI), Poblocki (two RBI) and Ryan Dominick (two RBI) contributed for the Storm. Robert Zagorski suffered the loss.

Despite squandering its chances, in the eighth inning a leadoff walk and a two-out error set up the game's only run off the bat of Danielle Kleeman who had an RBI single.

Kleeman (3-for-5, double, RBI), Cam-

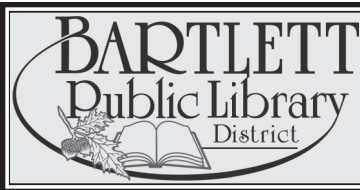

"Games are backlogged so you try and get them in," said Bartlett coach Jim Wolfsmith. "All the coaches want to and all the umpires want to, but ultimately you get to the safety question. We've got to keep people safe."

## IDNR reminds citizens to leave wild animals, birds alone

The Illinois Department of Natural Resources (IDNR) is reminding Illinois citizens to leave baby birds and wild animals alone. During the breeding season, well-meaning people may believe they are helping by taking possession of young wildlife such as young rabbits, fawn deer, baby birds and other animals that may appear to have been orphaned or abandoned. In nearly all cases, the birds and animals are still being fed and cared for by their parents, which likely stay away from nests or dens if people are present.

The Illinois Wildlife Code provides legal protection for wildlife. It is against the law to keep wild animals as pets, or to raise wild animals believed to have been abandoned. Additionally, agency responses to incidents involving wildlife can be costly to taxpayers. For example, in response to community concern about a young wild deer in McLean County this spring, IDNR and USDA Wildlife Services' personnel and other costs totaled nearly \$7,000 to investigate the matter and to capture and relocate the deer to a licensed wildlife rehabilitator.

All wild birds, except the rock pigeon, European starling and house sparrow, are protected by federal law. This includes protection of eggs, nests, and feathers. The IDNR works with the U.S. Fish and Wildlife Service to protect and manage birds in Illinois.

Some additional reminders about wildlife in Illinois:

- Birds often leave the nest before they can fly. These birds, known as fledglings, will live on the ground for a few days while they grow flight feathers, and you may hear them making noises calling for their par-

ents. They do this so their parents will continue to feed them, and it doesn't mean they are in trouble. Keep children and pets away.

- Do not attempt to rescue fawns. Fawns stay very still to conceal themselves until they are old enough to keep up with their mother. The mother will not stand near the fawns for fear of alerting predators to their presence. Leave fawns alone and the mother will return once you leave the area.
- It is illegal to feed wild deer. When deer congregate, it can facilitate the spread of disease and cause other unintended consequences.
- Wild birds and animals can become habituated to people when they are provided food. Do not leave pet food outside at night, clean up under bird feeders, secure the lids on garbage cans to keep raccoons and other wildlife out, and don't feed Canada geese in urban/suburban areas. Nuisance animals can become dangerous to people.
- Handling wild animals can result in the handler being bitten. According to the Centers for Disease Control, wild animals that bite a person must be euthanized immediately to be tested for rabies.

The IDNR urges everyone to enjoy wildlife by observing, but not interfering, and by leaving wildlife in the wild.

Anyone with questions about care for possibly abandoned wildlife can contact a licensed wildlife rehabilitator. # Village Board provided updated financial data

The Village Board of Trustees was updated on Bartlett's finances at its meeting on Tuesday, April 17.

Todd Dowden, finance director, delivered the treasurer's report as of February which is the 10th month of the fiscal year.

Total revenues to the village were at \$45.8 million and total expenditures \$50.9 million. The revenue side represents 60.5 percent of a budgeted \$75.6 million whereas at the same time last year they were at 130.8 percent of the previous budget, and expenditures were at 57.5 percent of a budgeted \$88.5 million while last year they were at 85.1 percent at the same time.

The largest category, the general

fund, showed \$18.6 million in revenues (85.3 percent of \$21.9 million budgeted) and \$17.5 million in expenditures (77.5 percent of \$22.6 million budgeted).

Major revenue categories showed the village has received \$9.4 million in property taxes (87 percent of \$10.8 million budgeted), \$6.6 million in water charges (84.4 percent of \$7.8 million), \$3.8 million in income taxes (90.9 percent of \$4.2 million), \$3.2 million in sewer charges (84.7 percent of \$3.8 million) and \$2.1 million in sales taxes (85.5 percent of \$2.4 million). The remaining seven categories have brought in between \$129,782 in the electric utility tax and \$924,491 in the motor fuel tax (MFT).

The golf fund has generated a net income of \$108,857 (\$1.9 million in revenues, \$1.8 million in expenditures) while the village budgeted a net income of \$46,695 for the entire year.

Dowden also gave an update on the MFT revenues for the month of January and sales tax revenues for the month of December.

"For January, we did receive \$93,233," Dowden said of the MFT. "That's just \$300 up from the same time last year."

"We received \$206,836 for the month of December," Dowden said of the sales tax. "That's up \$5,761, or just under three percent. So sales tax continues to do well."



## Illinois State Museum partnering to launch Illinois history website

The Illinois State Museum (ISM) is highlighting artifacts that tell the story of Illinois’ rich heritage as part of the state’s bicentennial celebration.

The museum has partnered with the Illinois Association of Museums to launch the “Story of Illinois” website, featuring objects from the ISM Illinois Legacy Collection, as well as collections from other museums across the state that help bring the state’s heritage to life.

“The collections from museums in Illinois help tell the unique story of Illinois, from statehood 200 years ago and beyond,” said Illinois State Museum Interim Director Robert Sill. “The new ‘Story of Illinois’ website will allow anyone to go online and sample some of the best of Illinois history, art, culture, and science.”

The new website, built by the ISM, previews some objects that will be on display in the “Bicentennial and Beyond: The Illinois Legacy Collection” exhibition, which will open at the Illinois State Museum in Springfield on June 30.

“You will find some rare, quirky, and beautiful objects on the website, such as the Lone Ranger’s saddle used by Brace Beemer from the Wabash County Museum, a ceremonial war club used by the Potawatomi Indians from the Chicago History Museum, a paint-

ing by Illinois native and American Impressionist Ivan Summers from the Cedarhurst Center for the Arts, and a photoelectric relay used at the Chicago Century of Progress Exposition of 1933-34,” said Illinois Association of Museums President Karen Everingham. “Each item has its own story to tell.”

While Illinois became a state 200 years ago, the collections held by Illinois museums help tell a story of Illinois dating back approximately 500 million years. From animals, fish, insects and plants to minerals, jewels, paintings, manuscripts, stone tools and fossils – the “Story of Illinois” website will feature some of the best artifacts and treasures from the collections of the participating museums.

Objects will be added to the website regularly during the celebration of the Illinois Bicentennial this year and promoted through the ISM Facebook page.
