Initial Presentations

ES Cross Cat Resource Proposal

• Council viewed PowerPoint presentation.

Questions:

- Some resource teachers travel, where will these resources be housed?
 - o Each resource teacher will receive the kits.
- Will this be available before school starts?
 - o Teachers will receive this on our DCD day, it will not available for teachers over the summer.
- Can PD be offered over the summer even if we don't have the materials?
 - o Many teachers switch positions, it would be difficult to provide PD for that reason. We could provide an overview of what it will look like at toward the end of the school year.

- Will there be training for paraeducators?
 - o No. They will not be getting formal training, but teachers can train and model for them.
- If a cross cat teacher is absent, could gen ed teachers get trained, so they can assist as well?
 - o These resources are for Special Education only.
- Is this replacing or supplementing Reading mastery?
 - o It is not replacing or supplementing. These new resources are addressing reading comprehension.
- How might 1st and 2nd graders be impacted by this new resource, given the reading levels of the texts provided?
 - o If a student is closer to a non-reader, they would not be using this resource.
- Are there any materials we are asking teachers to get rid of/pack up in order to move forward with these?
 - o No.
- By October 1st how much PD will teachers have been offered and is it mandatory?
 - Teachers will be expected to attend on DCD. August will be a half day and there will be optional PD on PPD.
- Will ELL special education teachers who travel to several buildings also have access to this resource?
 - o No. ELL itinerants are not part of the group that will receive this resource.
- What does the research on the resource indicate regarding the frequency of use for it to be effective?
 - o A minimum of 2 days a week would be appropriate, if they are not that far behind.
- Are ED classroom excluded?
 - o They are included.

 - o There will be a tech class coming forward regarding technology for MS.
- In the operational plan, is there a mention of mounting projectors in all elementary schools?

o No. They are not mounting them replacing with the large screen formats. They can be mounted or on a stand.
