Informational Updates

PE Waiver Update

- Council received update on PE Waivers
- Students in grades 7-12 may exempt physical education if they can show documentation of ongoing participation in a National/International sanctioned athletic program and participates in 15 or more hours of training, Monday Friday. Student will not be exempt from health class.

- Students in grades 9-12 who participate in interscholastic athletic programs may exempt P.E. at the start of the athletic season and return to P.E. after the state tournament. Students are assigned to a study hall during their P.E. class.
- Students in grades 7-8 whose schedule does not allow for elective opportunities may choose a P.E. exemption to be able to experience an electives course. Student is not exempt from health class.
- Students in grades 11-12 may request an exemption to replace P.E. with a post-secondary enrichment course. If the enrichment course is dropped, the student will lose their P.E. exemption and need to make up the class. Prerequisite for this exemption is 2 credits in independent P.E. class.

- MTSS guide will answer many frequently asked questions, regarding MTSS teams, data collections and interventions.

ES Coaching

- Council received an update on Title I strategy overview.
- Century Oaks, Harriet Gifford, Hillcrest and McKinley are currently implementing the coaching model.
- Students will receive 70 minutes of intervention/enrichment time per week.
- Teachers will receive weekly PLC meetings with a trained facilitator.
- Support in implementing intervention with fidelity.
- The strategy schools had more students meeting their expected growth targets in mathematics than non-Title I and other Title I schools.
- The strategy schools had more than expected overall growth in mathematics than the national norms and more overall growth than the other Title I schools and non-Title I schools.
- The strategy schools had similar overall growth in reading to other U-46 schools but still below the national average.
