 - Coordinator/Dual Language. Ms. Patricia Makishima has accepted the appointment of Coordinator for Dual Language. Ms. Makishima is currently serving as ELL Coordinator. Ms. Makishima has qualifications, work experience and leadership experience to continue to serve the District well as the Dual Language Coordinator.

The Board asked the timeframe for implementation of a Dual Language program. Dr. Torres indicated the goal is to implement dual language during the 2011-2012 school year for kindergarten across the District. Dr. Torres indicated that the program will go through the 8th grade.

- 2. <u>Coordinator/Elementary ELL</u>. Ms. Sylvia Rodriguez has been selected to serve as Coordinator for Elementary ELL. Ms. Rodriguez most recently served as literacy coach at Ontarioville Elementary.

Dr. Torres reviewed the information which now includes Nirav Mehta as Project Manager/Strategic Planning and Performance Management.
