Minutes of September 9, 2021 Meeting

- I. Call to order:** meeting was called to order at 7:03 pm. - III. Public comment:** There were 14 speakers for public comment:
- a) Christina Towner - district parent- spoke of opposition to masks and vaccine mandates

 - c) Tomasz Sobarnia - district parent - opposes masks mandates
 - d) Heather Mathews - district parent & CAC representative - as a health care worker, she commends the district on handling of pandemic and mandates.
 - e) Kevin Anderson - district parent - questioned how to get district updates when not leaving in district
 - f) Reyna - district parent - concerned about other parents and students not wearing masks or being vaccinated as required
 - g) Beverly James & Amanda Sumner - district parents - supports mask mandate
 - h) Kelly McElroy- district parent and employee - commended district on handling of emergency on September 8 that put several schools into hold in place measures.
 - i) Syed A - another district parent in support of mask mandates
 - j) Nilesh Borat - district parent shared ideas of how to help slow spread of virus in schools

- k) Jackie Gustafson - district parent, concerned about spread of virus
- l) Imani Wright - new district parent concerned about district effectively monitors mask wearing
- m) Nick Wright - opposes masks
